WHEREAS, The City's budget for FY2001-2002 does not list each State grant but contains two aggregate items, one indicating all Federal and one all State grant funds; and,

WHEREAS, The Department of Public Health has prepared a document entitled "Recurring FY 2001-2002 State Grants, Schedule A" that lists the estimated amount of each recurring grant provided by the State of California for FY2001-2002, the State agency that provides the grant, and the indirect costs of each grant, which is attached to this Resolution and is included in the Board of Supervisors File No. \_\_\_011771\_; and,
