6 **WHEREAS**, Under PUC Resolution No. 97-0202 dated July 8, 1997, the Public Utilities  
7 Commission awarded the HHW&P Contract No. HH-859, Moccasin-Newark Transmission  
8 Line Tower Painting Phase II; and,

9 **WHEREAS**, The official total amount of the contract was \$300,000.00; and

10 **WHEREAS**, The official start date for field construction work was established on  
11 September 9, 1997 with a contract completion date of August 8, 1998; and

12 **WHEREAS**, Contract Modification No. 1 was in the amount of \$10,000.00, a 3.3%  
13 increase of the original contract amount to purchase personnel safety equipment; and

14 **WHEREAS**, This Contract Modification No. 2 will increase the contract amount by  
15 \$70,000.00 to allow for painting the remaining 39 towers along transmission lines 3 and 4; and

16 **WHEREAS**, This Contract Modification No. 2 will extend construction completion date  
17 from August 8, 1998 and after the winter shutdown, these remaining towers will be painted by  
18 June 1, 1999; and

19 **WHEREAS**, Contract Modification No. 2 brings the total modified amount from  
20 \$310,000.00 to \$380,000.00, a 22.6% increase of the original contract amount; now  
21 Therefore, be it

22 **RESOLVED**, That Contract Modification No. 2 and extension of time for contract  
23 ~~completion for Hetch Hetchy Water & Power Contract No. HH-859, Moccasin-Newark~~  
24 **Transmission Line Tower Painting Phase II, are hereby approved.**


