11 Christopher Punongbayan, succeeding Deborah Escobedo, term expired, seat 4, must
12 have a demonstrated knowledge of and interest in the health, human service, educational, or
13 employment issues that affect immigrants residing in San Francisco, for the unexpired portion
14 of a two-year term ending June 6, 2009.

15 Angus McCarthy, succeeding himself, term expired, seat 7, must be an immigrant to
16 the United States who is appointed in accordance with Section 4.101 of the Charter. In
17 addition, members shall have a demonstrated knowledge of and interest in the health, human
18 service, educational, or employment issues that affect immigrants residing in San Francisco,
19 for the unexpired portion of a two-year term ending June 6, 2009.

20 Felix Fuentes, succeeding Samira McCoy, term expired, seat 8, must be an immigrant
21 to the United States who is appointed in accordance with Section 4.101 of the Charter. In
22 addition, members shall have a demonstrated knowledge of and interest in the health, human
23 service, educational, or employment issues that affect immigrants residing in San Francisco,
24 for the unexpired portion of a two-year term ending June 6, 2009.

Toye Moses, succeeding himself, term expired, seat 11, must be an immigrant to the United States who is appointed in accordance with Section 4.101 of the Charter. In addition, members shall have a demonstrated knowledge of and interest in the health, human service, educational, or employment issues that affect immigrants residing in San Francisco, for the unexpired portion of a two-year term ending June 6, 2009.
