

[Airport Professional Services Agreement - BEUMER Lifecycle Management, LLC - Operation and Maintenance of Airport Baggage Handling Systems - Not to Exceed \$30,000,000]

Resolution approving Award of Professional Services Agreement for Airport Contract No. 50409, for Operation and Maintenance of Airport Baggage Handling Systems, between BEUMER Lifecycle Management, LLC, and the City and County of San Francisco, acting by and through its Airport Commission, in an amount not to exceed \$30,000,000 for a term of three years, commencing on November 1, 2025, through October 31, 2028, with a single option to extend for two additional years, exercisable at the sole discretion of the Airport Commission, pursuant to Charter, Section 9.118(b).

WHEREAS, On September 16, 2025, pursuant to Resolution No. 25-0153, the Airport Commission awarded a Professional Services Agreement for Airport Contract No. 50409 for the Operations and Maintenance of Airport Baggage Handling Systems to BEUMER Lifecycle Management LLC, for a total not-to-exceed contract amount of \$30,000,000 for a term of three years, with a single option to extend for two additional years, exercisable at the sole discretion of the Airport Commission; and

WHEREAS, San Francisco Charter, Section 9.118(b), provides that the agreements entered into by a department, board or commission requiring anticipated expenditures by the City and County of ten million dollars, or a modification to such an agreement having an impact of more than \$500,000 shall be subject to approval by the Board of Supervisors by Resolution; and

WHEREAS, On March 5, 2025, the Office of Contract Administration approved Proprietary Article No. 12 for this Agreement for the procurement of operations and maintenance services of the baggage handling system equipment in Terminal 1, including

1 service and parts when repairs must be done by the manufacturer of the system, as well as
2 access to proprietary software, under Administrative Code, Chapter 21.5(d); and

3 WHEREAS, The Contract is on file with the Clerk of the Board of Supervisors in File
4 No. 250971, which is hereby declared to be a part of this Resolution as if set forth fully herein;
5 now, therefore, be it

6 RESOLVED, That the Board of Supervisors hereby approves the Award of
7 Professional Services Agreement for Airport Contract No. 50409 for Operation and
8 Maintenance of Airport Baggage Handling Systems between BEUMER Lifecycle
9 Management, LLC, and the City and County of San Francisco, acting by and through its Airport
10 Commission, for a not-to-exceed contract amount of \$30,000,000 for a term of three years,
11 with a single option to extend for two additional years, exercisable at the sole discretion of the
12 Airport Commission; and, be it

13 FURTHER RESOLVED, That within thirty (30) days of the Contract being fully
14 executed by all parties, the Airport Commission shall provide it to the Clerk of the Board for
15 inclusion in the official file.

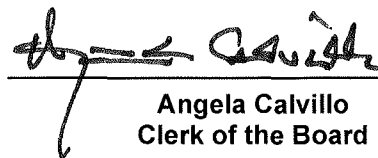

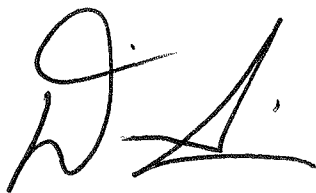
