8 organization whose primary mission is to raise funds to assist the Library in serving its patrons, and


9 WHEREAS, The San Francisco Public Library has a collection of periodicals and other printed

11 reformatted to be accessible to the public, and


12 WHEREAS, Earnings from the Hormel Endowment managed by the Friends and Foundation of




