3 **Resolution approving the San Francisco Unified School District and the First Five**  
4 **Commission's expenditure plans for the Public Education Enrichment Fund.**

6 WHEREAS, Charter Section 16.123-2 establishes the Public Education Enrichment  
7 Fund (the "fund"), and designates one-third of the fund for universal access to preschool, one-  
8 third for sports, library, arts and music programs and the remaining one-third of the fund, or in-  
9 kind services of equal value, for general education purposes; and,

10  
11 WHEREAS, in FY 2005-06, the fund requirement is \$10 million transferred from the  
12 General Fund; and,

13  
14 WHEREAS, the San Francisco Unified School District and the First Five Commission  
15 have submitted expenditure plans that meet the prescribed uses of the fund as outlined in the  
16 Charter; and,

18 WHEREAS, the Controller's Office has reviewed the expenditure plans and has  
19 provided comment to the Mayor and the Board of Supervisors; now, therefore, be it

20  
21 RESOLVED, By the Board of Supervisors of the City and County of San Francisco that  
22 it does hereby approve the expenditure plan, as proposed by the First Five Commission, for  
23 fiscal year 2005-2006; and, be it

25 FURTHER RESOLVED, That the Board of Supervisors hereby approves the San  
Francisco Unified School District fiscal year 2005-2006 plan for sports, library, arts and music  
but amends the plan for general education by allocating \$102,972 to the Controller's Office for  
the City Services Auditor function.




