Section 3. Allow \$500,000 of low income/nonprofit funding to be utilized for the general GoSolarSF program, leaving \$1,000,000 earmarked for low income/nonprofit projects. If \$1 million is spent by June 30, 2009, the PUC intends to seek an appropriation for an additional \$500,000 earmarked for low income/nonprofit projects.

Section 4. The San Francisco Environment Code is hereby amended by amending Chapter 18-7.5 to read as follows:

Section 18.7-5. ALLOCATION OF PROGRAM FUNDING AMONG TYPES OF BUILDINGS.

1 For this pilot program, funds shall be allocated as follows: ~~\$1,500,000~~ 1,000,000 to
2 buildings that are owned and operated by non-profit organizations or single and multifamily
3 residential applicants that are certified by the Mayor's Office of Housing as earning at or below
4
5 the San Francisco median income or CARE and CalHome participants or participants in the
6 CPUC Low Income program under CSI.




