12	Be it ordained by the People of the City and County of San Francisco:
13	Section 1. Findings.
14	The City and County of San Francisco ("City") wishes to establish a framework to honor
15	those individuals whose artistic and cultural contributions are integral to the unique character
16	of San Francisco. The San Francisco Public Library has established a model process to
17	identify and select Poet Laureates, which has been replicated in the selection of a Drag
18	Laureate.
19	Artists and members of the drag community make significant cultural contributions to
20	the unique character of San Francisco without direct compensation. In order to foster
21	sustained cultural and artistic development, the City will highlight individuals who best
22	represent our values, and provide those individuals with stipends through the Library
23	Laureates Program. In exchange, Laureates will serve as cultural ambassadors of the City.
24	Section 2. The Administrative Code is hereby amended by adding Chapter 123,
25	consisting of Sections 123.1, 123.2, 123.3, 123.4, and 123.5 to read as follows:

1 CHAPTER 123: LIBRARY LAUREATE PROGRAMS 2 SEC. 123.1. DEFINITIONS. 3 For purposes of this Chapter 123, the following definitions shall apply: 4 "Applicant" means an individual who submitted an Application in response to an 5 Invitation for Applications, or is the subject of a third-party nomination submitted in response to an 6 Invitation for Applications. 7 "Application" means a response to an Invitation for Applications following guidelines 8 outlined in the Invitation for Applications. 9 "City" means the City and County of San Francisco. "Finalist" means one or more individuals selected for the Laureate Program who enter 10 11 into a Laureate Agreement with the Library. 12 "Invitation for Applications" means an invitation to submit Applications for individuals 13 to become a Laureate or Finalist(s). 14 "Laureate" means an individual selected for a Laureate Program who enters into a 15 Laureate Agreement with the Library. 16 "Laureate Agreement" means a written agreement between the Library and the 17 Laureate or Finalist wherein the Library agrees to provide a stipend to the Laureate or Finalist in 18 recognition of their leadership and achievements and in exchange for their service to the City. 19 "Laureate Program" means an honorary program through which the City selects 20 individuals through a competitive process to become a Laureate or Finalist to receive a stipend in recognition of the Laureate's or Finalist's achievements, leadership, and cultural contributions, and in 21 22 exchange for their service to the City. 23 "Library" means the San Francisco Public Library. 24 SEC. 123.2. LIBRARY LAUREATE PROGRAMS.

19	Laureate and any Finalist(s) from the Library's recommendation(s) for each term of each Laureate

22	The Laureate Agreement shall specify the duties of the Laureate or Finalist in serving and

LEGISLATIVE DIGEST

[Administrative Code - Library Laureate Programs]

Ordinance amending the Administrative Code to establish the Library Laureate Programs, authorizing the Library to grant stipends to individuals selected through a competitive process as Laureates or Finalists in recognition of their achievements, leadership, and cultural contributions, and in exchange for their service to the City.

Existing Law

Existing law imposes certain contracting requirements and restrictions on the City's award of grants set forth in Chapter 21G of the Administrative Code. Under existing law, stipends granted to individuals through an honorary laureate program are subject to Chapter 21G.

Amendments to Current Law

The proposed ordinance adds Chapter 123 to the Administrative Code to establish the Library Laureate Programs. The ordinance would authorize the Library to enter into agreements with, and grant stipends to, individuals selected through a competitive process as Laureates or Finalists, while exempting the Programs from certain restrictions imposed by Chapter 21G. The proposed ordinance sets forth requirements for the Laureate Programs, including the publication of invitations for applications, evaluation and ranking of applicants based upon criteria established by the Library, final selection of Laureates and Finalists by the Mayor, and that Laureate agreements with selected individuals contain certain specified terms.

Background Information

The Library has established a model process to identify and select Poet Laureates, which has been replicated in the selection of a Drag Laureate. The stipends granted to Laureates are subject to certain requirements contained in Chapter 21G that do not fit the Program. For example, Chapter 21G requires that a City grantee be registered to do business in the State and City, and that grantee maintain certain insurance, but Laureate Agreements are entered into with individuals who may not maintain a business license or such insurance.
