3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **accept retroactively and expend a new grant in the amount of \$2,500 from the State of**  
5 **California Department of Health Services (CDHS), to implement a car seat bank**  
6 **program; for the period of December 15, 2002 through January 31, 2003.**

8 WHEREAS, SFDPH has applied for and been awarded a grant from CDHS in the  
9 amount of \$2,500 to provide child safety seats and information to pregnant and parenting  
10 teens in San Francisco; and,

11 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to  
12 comply with the terms of an agreement (the "Agreement"), a copy of which is on file with the  
13 Clerk of the Board of Supervisors in File No. 030233, which is hereby declared to  
14 be a part of this resolution as if set forth fully herein; and,

15 WHEREAS, The SFDPH proposes to maximize use of available grant funds on  
16 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

17 **RESOLVED**, That SFDPH is hereby authorized to accept retroactively and expend a  
18 grant in the amount of \$2,500 from CDHS; and, be it

19 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of  
20 indirect costs in the budget of the agreement; and, be it

21 **FURTHER RESOLVED**, That the Director of Health is authorized to enter into the  
22 agreement on behalf of the City.






