9 WHEREAS, The City and County of San Francisco wishes to provide security  
10 services to its employees, clients and the general public at 20 locations; and

11 WHEREAS, The Board of Supervisors approved this contract by Resolution No.  
12 201-08 and subsequent Ordinance No. 306-08 in 2008; and

13 WHEREAS, The Human Services Agency wishes to renew this contract as a  
14 result of a new Request for Proposal Process (RFP) from February 1, 2014, through  
15 January 31, 2018, including three additional one-year options for a total new contract  
16 amount of \$ 19,785,392; and

17 WHEREAS, The City and County of San Francisco is providing financial support  
18 with Federal, State and General Funds; now, therefore, be it

19 RESOLVED, That the Board of Supervisors retroactively authorizes Executive  
20 Director of the Human Services Agency to approve the new contract with Guardsmark,  
21 LLC, to provide security services to the Human Services Agency for its employees, clients  
22 and the general public for the period of February 1, 2014, through January 31, 2015, and  
23 to exercise up to three additional option years through January 31, 2018, in the amount of  
24 \$19,785,392.

1           FURTHER RESOLVED, That within thirty (30) days of the contract being fully  
2 executed by all parties the Human Services Agency shall provide the final contract to the  
3 Clerk of the Board for inclusion into the file.
