9 **MOVED,** That the Board of Supervisors of the City and County of San Francisco does  
10 hereby add Section-Rule 5.9.5 to its Rules of Order as follows:

11 **5.9.5. Business Tax Restructuring Committee.** The Business Tax Restructuring  
12 Committee shall be referred measures related to restructuring the City and County of San  
13 Francisco business tax. ~~The Business Tax Restructuring Committee shall be a fiscal~~  
14 ~~committee within the meaning of Administrative Code Section 2.6-3.~~

15 FURTHER MOVED, That the Board of Supervisors amends Rule 5.10 of its Rules of  
16 Order as follows:

17 **5.10. Fiscal Committees.** In accordance with Administrative Code Section 2.6-3  
18 concerning fiscal impact, the Finance Committee shall be a "fiscal committee" of the Board,  
19 the Business Tax Restructuring Committee shall be a "fiscal committee" for the sole purpose  
20 of the consideration of business tax issues, the Audit, Labor and Government Efficiency  
21 Committee shall be a "fiscal committee" of the Board for purposes of considering proposed  
22 memoranda of understanding with City employee unions, and the other committees of the  
23 Board, solely for the purpose of considering grants to the City within their subject areas, shall  
24 also be considered "fiscal committees."


