3 **Resolution approving the application for grant funds for California Climate Investments**
4 **Urban Greening Program administered by the California Natural Resources Agency.**

6 WHEREAS, The Legislature and Governor of the State of California have provided
7 funds for the program shown above; and

8 WHEREAS, The California Natural Resources Agency has been delegated the
9 responsibility for the administration of this grant program, establishing necessary procedures;
10 and

11 WHEREAS, Said procedures established by the California Natural Resources Agency
12 require a Resolution application(s) to the State; and

13 WHEREAS, The applicant, if selected, will enter into an agreement with the State of
14 California to carry out the Project; now, therefore, be it

15 RESOLVED That the San Francisco Board of Supervisors approves the filing of an
16 application for the Mansell Street Greening Project, which will enhance the Mansell Street
17 medians between Bowdoin Street and San Bruno Avenue and include tree planting at existing
18 sites on residential streets adjacent to Mansell Street; and, be it

19 FURTHUR RESOLVED, That the San Francisco Board of Supervisors certifies the
20 applicant, Public Works, understands the assurances and certification in the application; and,
21 be it

22 FURTHUR RESOLVED, Certifies that Public Works will have sufficient funds to
23 operate and maintain the project consistent with the land tenure requirements, or will secure
24 the resources to do so; and, be it

1 FURTHUR RESOLVED, That Public Works will comply with the provisions of Section
2 1771.5 of the State Labor Code; and, be it

3 FURTHUR RESOLVED, That, if applicable, certifies that the project will comply with
4 any laws and regulations including, but not limited to, legal requirements for building codes,
5 health and safety codes, disabled access laws, environmental laws and, that prior to
6 commencement of construction, all applicable permits will have been obtained; and, be it

7 FURTHUR RESOLVED, Certifies, that Public Works will work towards the Governor's
8 State Planning Priorities intended to promote equity, strengthen the economy, protect the
9 environment, and promote public health and safety as included in Government Code, Section
10 65041.1; and, be it

11 FURTHUR RESOLVED, Appoints the Bureau of Urban Forestry Contracts and Grants
12 Manager, or designee, as agent to conduct all negotiations, execute and submit all documents
13 including, but not limited to applications, agreements, payment requests and so on, which
14 may be necessary for the completion of the aforementioned projects.


