4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
5 **accept and expend retroactively a grant in the amount of \$985,000 from the California**  
6 **Department of Mental Health (CDMH) for the first year of the San Francisco City and**  
7 **County "Older Adult Partnership Assessment and Care Management" project to**  
8 **develop and implement an older adult system of care; for the period of Fiscal Year 2001**  
9 **through Fiscal Year 2002.**

11 WHEREAS, The SFDPH has applied for and been awarded a grant from the CDMH in  
12 the amount of \$985,000 for the first year of this project; and,

13 WHEREAS, As a condition of receiving the grant funds, CDMH requires the City to  
14 enter into an agreement, "Scope of Services and Grant Application", (the "Agreement"), a  
15 copy of which is on file with the Clerk of the Board of Supervisors in File No. 011842,  
16 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$105,337; now,  
18 therefore, be it


19 RESOLVED, That the SFDPH is hereby authorized to accept and expend retroactively  
20 a grant in the amount of \$985,000 from CDMH; and, be it

21 FURTHER RESOLVED, That the SFDPH is hereby authorized to accept and expend  
22 the grant funds in accordance with the requirements set forth in the Agreement pursuant to  
23 San Francisco Administrative Code section 10-170-1; and, be it

24 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
25 Agreement in behalf of the City; and, be it

1 FURTHER RESOLVED, That the Controller is directed to designate the position  
2 created under the grant as a "G" or grant-funded position, which would terminate when the  
3 grant expires.


