

1 [Professional Services Contract Indemnification]

2 AUTHORIZING THE SAN FRANCISCO SHERIFF'S DEPARTMENT TO ENTER INTO AN  
3 AGREEMENT WITH MR. BEN DORCY FOR MANDATORY CERTIFIED CPR AND FIRST AID  
4 TRAINING, WHICH AGREEMENT PROVIDES FOR MUTUAL INDEMNIFICATION FROM  
5 CLAIMS OR OTHER DAMAGES WHICH ARISE AS A RESULT OF PERFORMANCE UNDER  
6 SAID AGREEMENT.

8 WHEREAS, The Sheriff's Department is required to obtain certified CPR and First Aid training  
9 for staff that meets the requirements set by the Board of Corrections and Standards and Training for  
10 Corrections Program; and,

11 WHEREAS, Mr. Ben Dorcy is willing and able to provide such services on the condition that  
12 each party agrees to indemnify the other from claims or other damages which may arise as a result of  
13 performance under the agreement; now, therefore, be it

14 RESOLVED, That the Board of Supervisors of the City and County of San Francisco authorizes  
15 the Sheriff's Department to enter into an agreement with Mr. Ben Dorcy for the provision of mandatory  
16 certified CPR and First Aid training, which agreement contains the following dual indemnification  
17 provision:

18 Contractor agrees to indemnify, defend, and hold harmless the City, its officers, agents, and employees  
19 from and against any claims, damages, expenses or liabilities arising out of the performance of this  
20 Agreement without limitations, excepting such claims, damages, expenses or liabilities for loss or  
21 damage to any property or from death or injury to any person or persons in proportion to or to the  
22 extent such claims, damages, expenses, or liabilities are caused by or result from the negligent or  
23 intentional acts or omissions of the City, its officers, agents or employees.

24 City agrees to indemnify, defend, and hold harmless the Contractor, its officers, agents, and employees  
25 from and against any claims, damages, expenses or liabilities arising out of the performance of this

1 Agreement without limitations, excepting such claims, damages, expenses or liabilities for loss or  
2 damage to any property or from death or injury to any person or persons in proportion to or to the  
3 extent such claims, damages, expenses, or liabilities are caused by or result from the negligent or  
4 intentional acts or omissions of the Contractor, its officers, agents or employees.


