ORDINANCE NO. 32-04

1 [Authorizing an alternative procedure for establishing property and business improvement
2 districts.]

3 **Ordinance amending Article 15 of the Business and Tax Regulations Code by**
4 **amending Sections 1510 and 1511 to authorize the Board of Supervisors to initiate**
5 **proceedings to establish property and business improvement districts upon receipt of**
6 **a petition signed by property owners responsible for 30 percent of the proposed**
7 **assessment; authorizing such districts to be formed for a term of up to 15 years;**
8 **authorizing such districts to encompass and assess residential property; authorizing**
9 **such districts to recover start-up costs through assessments; authorizing the Board of**
10 **Supervisors to disestablish a district without cause upon a supermajority vote of the**
11 **Board; requiring a minimum level of representation by business owners on the**
12 **governing body of the proposed district; requiring that the Clerk of the Board notify**
13 **business owners in English, Spanish and Cantonese when a petition for district**
14 **formation is received; making technical corrections to Sections 1534 and 1535,**
15 **repealing existing Sections 1513 through 1533 and 1540 through 1591, and making**
16 **environmental findings.**

20 Be it ordained by the People of the City and County of San Francisco:

21 Section 1. Findings

22 The Planning Department has determined that the actions contemplated in this
23 Ordinance are not defined as a project under the California Environmental Quality Act
24 ("CEQA"), California Public Resources Code sections 21000 et seq., and 14 CCR section
25 15000 et seq., CEQA Guidelines section 15378(b)(4). Said determination is on file with the

1 Clerk of the Board of Supervisors in File No. 031609 and is incorporated herein by this
2 reference.

3 Section 2. The Board of Supervisors finds as follows:

4 (a) It is in the public interest to enable the City to fund property-related improvements,
5 maintenance and activities through the levy of assessments upon the residential, as well as commercial,
6 real property that derives special benefits from those improvements, maintenance and activities.

7 (b) In many of San Francisco's neighborhoods, commercial and residential properties are
8 intermingled, such that both commercial and residential properties are both likely to benefit specially
9 from property-related improvements, maintenance and activities. In San Francisco's unique urban
10 environment, even purely residential neighborhoods are likely to benefit from such activities.

11 (c) Accordingly, it is appropriate in San Francisco that property and business improvement
12 and maintenance districts be able to encompass commercial, mixed use, and residential neighborhoods
13 in which the property owners desire to avail themselves of the benefits provided by such a district.

14 (d) In order to give such districts increased flexibility for planning and financing
15 improvements and activities, it is appropriate to authorize the formation of new assessment districts
16 with a maximum terms of up to 2015 years.

17 Section 23. The San Francisco Business and Tax Regulations Code is hereby
18 amended by amending Article 15, to read as follows:

19 SEC. 1510. ~~SHORT TITLE.~~

20 ~~This Article shall be cited and referred to as the San Francisco Business Improvement~~
21 ~~District ("BID") Procedure Code.~~

22 SEC. 1511. PURPOSE.

23 (a) State law provides procedures to form property and business improvement districts.

24 This Article provides authority for the City to invoke that those state procedures
25 apply if those procedures to residential property that would not be covered were the City to follow

1 the state law exclusively. This Article incorporates the state law and then specifies how the Board of
2 Supervisors may choose to augment the state law provisions by choosing to: (1) reduce the percentage
3 of petitions required from owners in order to initiate formation; (2) have the district encompass and
4 assess residential property; or (3) extend the term of the district to a maximum of 2015 years, unless
5 a longer term is authorized by state law; or (4) authorize the district to recover through
6 assessments the costs incurred in its formation. In addition, this Article augments state law by
7 authorizing the Board of Supervisors to disestablish a district upon a supermajority vote of the
8 Board, requiring the Clerk of the Board to notify business owners in English, Cantonese and
9 Spanish when a petition for district formation is received, and setting minimum levels of
10 representation by business owners on the governing body of the proposed district.~~an~~
11 ~~alternative procedure by which the Board may finance improvements, services, and activities that~~
12 ~~provide special benefit to property within specific activities that provide special benefit to property~~
13 ~~within specific and limited areas.~~

14 (b) Through proceedings under this Article, the Board may establish property and
15 business improvement and maintenance districts and may finance enhancements through
16 annual assessments apportioned among parcels of real property within such districts. It is the
17 intent of this Article to provide a vehicle for financing enhancements which supplement and
18 compliment existing services. District formation and assessment proceedings may not be
19 initiated under this Article to finance replacing or supplanting existing City services. Nothing
20 herein shall be construed as prohibiting the establishment of districts to finance local capital
21 improvements under any other ordinance or any other law of the State of California.

22 SEC. 1511. SAN FRANCISCO PROCEDURAL AND SUBSTANTIVE AUGMENTATION OF
23 STATE LAW REQUIREMENTS GOVERNING PROPERTY AND BUSINESS IMPROVEMENT
24 DISTRICTS.

25 ///

1 In forming assessment districts that will fund improvements and services that confer special
2 benefit on businesses, residential, commercial or residential and commercial property, the Board of
3 Supervisors may elect to use the procedures set forth in California Streets & Highways Code Sections
4 36600 et seq. or may elect to use those procedures except as modified herein. The Board of
5 Supervisors shall be bound by, and comply with, the applicable state law governing the formation of
6 property and business improvement and maintenance districts in all other respects not inconsistent with
7 this Article when forming an assessment district to fund improvements and services that provide special
8 benefits to businesses, commercial and/or residential property.

9 (a) Notwithstanding Streets & Highways Code Section 36621(a) or any other provision of
10 state law, the Board of Supervisors may initiate proceedings to establish a property and business
11 improvement district upon receipt of a petition signed by property owners in the proposed district who
12 will pay at least 30 percent of the assessments proposed to be levied. The amount of assessment
13 attributable to property owned by the same property owner that is in excess of 40 percent of the amount
14 of all assessments proposed to be levied, shall not be included in determining whether the petition is
15 signed by the property owners who will pay the requisite percentage of assessments. Where the
16 Board initiates proceedings pursuant to this subsection, the Board shall conduct a protest
17 ballot proceeding in accordance with Article XIII D of the California Constitution
18 notwithstanding any language to the contrary of Streets & Highways Code Section 36623.

19 (b) Notwithstanding Streets & Highways Code Section 36622(h) or any other provision of
20 state law, the Board of Supervisors may form a district authorized to levy assessments for a maximum
21 term of up to ~~twenty~~15 years, except where a longer term is authorized by state law.

22 (c) Notwithstanding Streets & Highways Code Section 36632(b) or any other provision of
23 state law, the Board of Supervisors may establish an assessment district pursuant to this Article that
24 that encompasses, and levies assessments upon, and funds improvements and services that specially
25 benefit, properties zoned for residential use.

1 (d) The Board of Supervisors may authorize an assessment district formed pursuant
2 to this Article to recover through assessments the costs incurred in forming the district,

3 including:

4 (1) The costs of preparation of the management plan and engineer's report required
5 by state law;

6 (2) The cost of circulating and submitting the petition to the Board of Supervisors
7 seeking establishment of the district;

8 (3) The costs of printing, advertising and the giving of published, posted or mailed
9 notices;

10 (4) Compensation of any engineer or attorney employed to render services in
11 proceedings under this Article or Streets and Highway Code Sections 36600 et seq.; and

12 (5) Costs associated with any ballot proceedings required by law for approval of a
13 new or increased assessment.

14 If the district will be authorized to recover these costs, the management plan required
15 pursuant to Streets & Highways Code Section 36622 shall specify the formation costs eligible
16 for recovery through assessments, the schedule for recovery of those costs, and the basis for
17 determining the amount of the additional assessment for recovery of costs, including the
18 maximum amount of the additional assessment, expressed either as a dollar amount, or as a
19 percentage of the underlying assessment.

20 (e) Notwithstanding Streets & Highways Code Section 36670 or any other provision
21 of state law, the Board of Supervisors may, by a supermajority vote of eight or more
22 members, notice a hearing and initiate proceedings to disestablish for any reason a district
23 formed after the effective date of this section. Where the Board of Supervisors seeks to
24 disestablish a district in circumstances not authorized under Streets & Highways Code
25 Section 36670, both the resolution of intention to disestablish the district and any final

1 resolution to disestablish the district shall be subject to a supermajority vote of eight or more
2 members. This paragraph shall not be applicable where the district has outstanding bonded
3 indebtedness.

4 (f) The management plan submitted for each proposed district subject to this
5 Article shall set forth minimum requirements to ensure adequate representation of business
6 owners located within the district who do not own, or have an ownership interest in,
7 commercial property located within the district. Not less than 20 percent of voting members
8 the governing body of the district shall be such business owners. Where warranted by the
9 circumstances in a proposed district, the Board of Supervisors may require that the
10 management plan provide a greater level of business owner representation.

11 (g) Not less than 30 days after the Clerk of the Board receives a completed petition
12 seeking formation of a district pursuant to this Article, the Clerk shall mail notice to all
13 businesses located within the proposed district holding a current registration certificate issued
14 by the Tax Collector. The notice shall be in English, Spanish and Cantonese, and shall inform
15 the recipients that (1) a petition for formation of a property and business improvement district
16 has been received; (2) if the district is formed, it would authorize assessments against
17 property and/or businesses in the district and (3) that formation of the district is subject to the
18 approval of the Board of Supervisors following public hearings and a vote by persons subject
19 to the assessment (unless the petition was signed by persons responsible for over 50 percent
20 of the assessment, and such vote is not required pursuant to Streets & Highways Code
21 Section 36623). The notice shall also describe how recipients may obtain further information
22 about the petition and proposed district.

23 *SEC. 1513. WAIVER/ORDERS FINAL*

24 *All objections not made within the time or manner herein provided are waived. All decisions*
25 *and determinations of the Board, upon notice and hearing, shall be final and conclusive upon all*

10 ~~———No step in any proceeding shall be invalidated or affected by any error or mistake or~~
11 ~~departure from the provisions of this Article as to the officer or person posting or publishing or~~

13 ~~matter when such notice is actually given for the time required.~~

Ordinance amending Article 15 of the Business and Tax Regulations Code by amending Sections 1510 and 1511 to authorize the Board of Supervisors to initiate proceedings to establish property and business improvement districts upon receipt of a petition signed by property owners responsible for 30 percent of the proposed assessment; authorizing such districts to be formed for a term of up to 15 years; authorizing such districts to encompass and assess residential property; authorizing such districts to recover start-up costs through assessments; authorizing the Board of Supervisors to disestablish a district without cause upon a supermajority vote of the Board; requiring a minimum level of representation by business owners on the governing body of the proposed district; requiring that the Clerk of the Board notify business owners in English, Spanish and Cantonese when a petition for district formation is received; making technical corrections to Sections 1534 and 1535, repealing existing Sections 1513 through 1533 and 1540 through 1591, and making environmental findings.
