3 **Resolution approving the application for grant funds for the Urban Greening Grant**  
4 **Program under the Safe Drinking Water, Water Quality and Supply, Flood Control, River**  
5 **and Coastal Protection Bond Act of 2006 (Proposition 84) for the Cayuga Playground.**

7 WHEREAS, The Legislature and Governor of the State of California have provided  
8 funds for the program shown above; and

9 WHEREAS, The Strategic Growth Council has been delegated the responsibility for the  
10 administration of this grant program, establishing necessary procedures; and

11 WHEREAS, Said procedures established by the Strategic Growth Council require a  
12 resolution certifying the approval of application by the Applicant's governing board before  
13 submission of said application to the State; and

14 WHEREAS, The applicant, if selected, will enter into an agreement with the State of  
15 California to carry out the Project; now, therefore, be it

16 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
17 approves the filing of an application for the Cayuga Playground; and

18 FURTHER RESOLVED, That the Board of Supervisors certifies that applicant  
19 understands the assurances and certification in the application; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors certifies that applicant or title  
21 holder will have sufficient funds to operate and maintain the project consistent with the land  
22 tenure requirements; or will secure the resources to do so; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors certifies that it will comply with  
24 the provisions of Section 1771.8 of the State Labor Code regarding payment of prevailing  
25 wages on Projects awarded Proposition 50 Funds; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors certifies that, if applicable, the  
2 project will comply with any laws and regulations including, but not limited to, legal  
3 requirements for building codes, health and safety codes, disabled access laws,  
4 environmental laws and, that prior to commencement of construction, all applicable permits  
5 will have been obtained; and, be it

6 FURTHER RESOLVED, That the Board of Supervisors certifies that applicant will work  
7 towards the Governor's State Planning Priorities intended to promote equity, strengthen the  
8 economy, protect the environment, and promote public health and safety as included in,  
9 Government Code Section 65041.1; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors appoints the General Manager  
11 for Recreation and Parks Department, or designee, as agent to conduct all negotiations,  
12 execute and submit all documents including, but not limited to applications, agreements,  
13 payment requests and so on, which may be necessary for the completion of the  
14 aforementioned project(s).
