

[Recreation and Park Department – Marina Small Craft Harbor Fees.]

Ordinance making environmental findings and amending San Francisco Park Code, Article 12, Section 12.11 to increase the West Harbor berth rental fees in fiscal year 2012-2013, or upon completion of the West Harbor renovations.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 081328 and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.11, to read as follows:

SEC. 12.11. MARINA FEES.

The following fees shall be charged for goods and services at the San Francisco Marina Small Craft Harbor:

(a) Berth Rental Fees. The charges shall be based on the overall length of the entire vessel or the length of the berth, which ever is greater.



14 (j) Adjustment of Fees. The berth rental and guest dock fees for the West Harbor shall
 15 be increased, without further action of the Board of Supervisors, for Fiscal Year 2006 – 2007
 16 by twenty (20) percent, and for Fiscal Years 2007 – 2008, 2008--2009, 2009 – 2010, by four
 17 (4) percent per year. Thereafter the berth rental and guest dock fees shall be adjusted in
 18 accordance with Section 12.20 of this article.

19 The berth rental and guest dock fees for the East Harbor shall be increased, without
 20 further action of the Board of Supervisors, for Fiscal Years 2006 – 2007, 2007 – 2008, 2008 –
 21 2009 by twelve (12) percent. Thereafter the berth rental and guest dock fees shall be
 22 adjusted in accordance with Section 12.20 of this article.


