10 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby

12 *County of San Francisco*, San Francisco Superior Court, Case No. CGC-15-547840 by the
13 payment of \$72,500. The lawsuit involves a Utility Users Tax refund.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 September 9, 2015, and the following parties were named in the lawsuit: Plaintiff T-Mobile
16 West, LLC and Defendant City and County of San Francisco.


