4 **and County of San Francisco for \$125,000; the lawsuit was filed on May 2, 2023, in San**
5 **Francisco Superior Court, Case No. CGC-23-606217; entitled Telesia Telsee v. City and**
6 **County of San Francisco, et al.; the lawsuit involves alleged personal injury from a**
7 **vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Telesia Telsee v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-606217 by the
13 payment of \$125,000. The lawsuit involves alleged personal injury from a vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May
15 2, 2023, and the following parties were named in the lawsuit: Plaintiff Telesia Telsee;
16 Defendants City and County of San Francisco, Officer Robert Spencer Brown.
