
2 Motion Approving Final Map of 1801-1807 Polk Street, A Mixed-Use

11 "1801-1807 Polk Street, A Mixed-Use Condominium-Project".


12 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as
