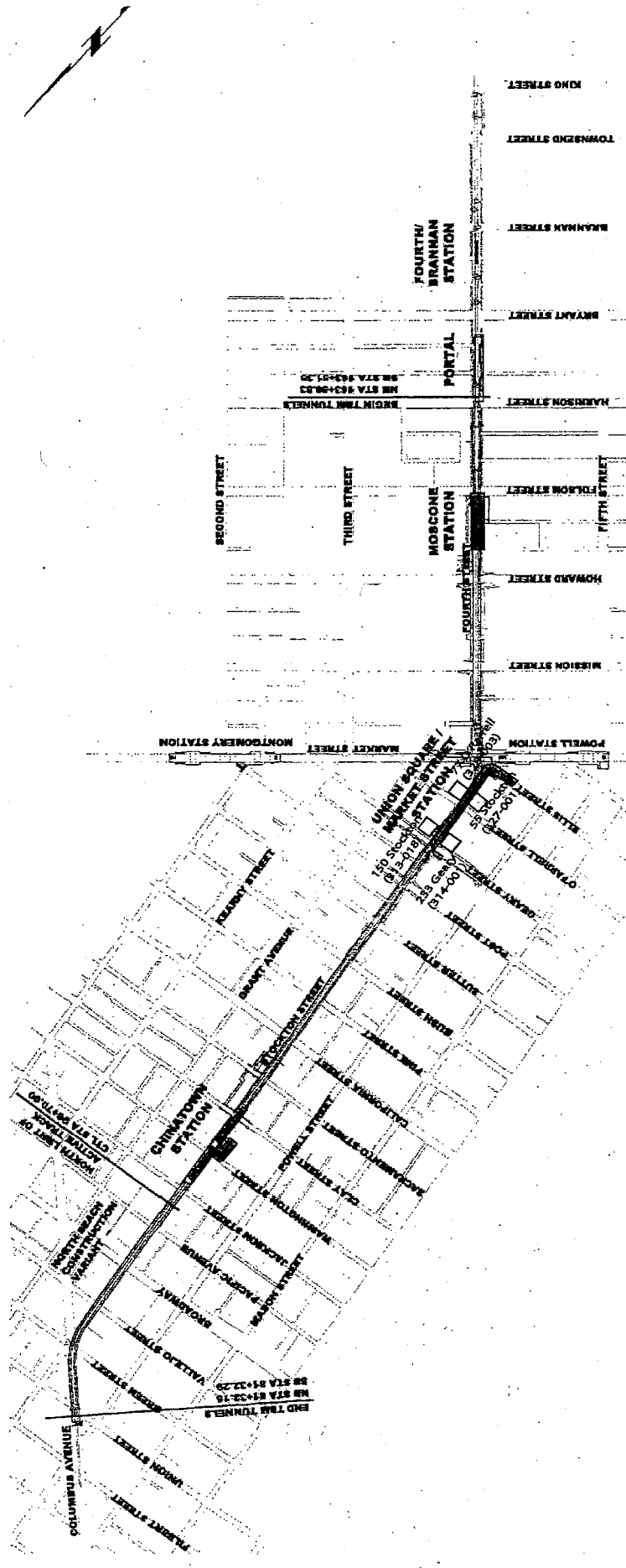

The headwall piles cross the property line approximately 107.2 feet below the surface of the ground. The bottom of the pile is approximately 158 feet below the surface of the ground. The headwall pile encroaches approximately 3 feet 11.25 inches onto the site over its entire Stockton Street frontage.

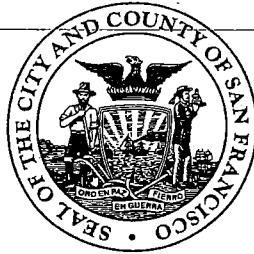
