10	Be it ordained by the People of the City and County of San Francisco:
11	
12	Section 1. The Administrative Code is hereby amended by
13	renumbering Section 10.100-288 as Section 10.100-287 and revising it, to read as follows:
14	SEC. <u>10.100-287</u> <u>10.100-288</u> . SAN FRANCISCO CHILDREN AND FAMILIES TRUST FUND.
15	(a) Establishment of Fund. The San Francisco Children and Families First Trust
16	Fund is established as a category four fund to receive all grants, gifts, or bequests of money
17	made to or for the benefit of the San Francisco Children and Families First Commission $\underline{\mathit{from}}$
18	form public or private sources to be used for early childhood development programs.
19	(b) Use of Fund. Moneys allocated to the fund shall be expended only for the
20	purposes authorized by the California Children and Families First Act and in accordance with
21	the San Francisco County Strategic Plan approved by the San Francisco Children and
22	Families First Commission. All monies shall be expended for the specific purpose such grant
23	gift, or bequest was made.

1	Section 2. The Administrative Code is hereby amended by adding a new
2	Section 10.100-288 to read as follows:
3	SEC. 10.100-288. SAN FRANCISCO CITY COLLEGE ENROLLMENT FEE ASSISTANCE
4	<u>FUND.</u>
5	(a) Establishment of Fund. The San Francisco City College Enrollment Fee Assistance Fund
6	("the Fund") is hereby established as a category four fund to provide financial assistance to students at
7	City College of San Francisco ("City College"), as further specified in subsection (c).
8	(b) Sources of Funds. The Fund may receive any legally available monies appropriated for
9	this purpose.
10	(c) Use of Funds. The Department of Children, Youth, and Their Families ("the Department")
11	shall use monies in the Fund to make block grants to City College to offset enrollment fees and provide
12	other education-related financial support for students who are enrolled in credit courses at City
13	College and who: (1) maintain their legal residence or domicile in San Francisco, or (2) are an
14	employee of the City and County of San Francisco, the San Francisco Unified School District, or City
15	College ("Eligible Students"). As a condition of accepting the monies, City College shall agree to use
16	the block grants to: (1) reduce or waive enrollment fees for Eligible Students, less any state or federal
17	financial aid the student is currently receiving for his or her education; or (2) for Eligible Students who
18	are receiving other financial aid covering their enrollment fees, for other education-related financial
19	support, including but not limited to monies for the purchase of required books and supplies, lab fees,
20	and activity fees, as specified in the block grant agreement. Benefits from the block grant program
21	need not be based on individual need, but no student shall receive benefits worth more than \$1,000
22	from the program for any academic year. For purposes of this Section 10.100-288, "employee" means
23	someone working for that employer at least 20 hours per week on average.
24	(d) Administration and Oversight of Fund. The Department shall administer the Fund.
25	

1	(1) The Department and City College shall develop and execute an agreement
2	governing the block grants and the process for applying for, calculating, awarding, and disbursing
3	payments to individual students. The agreement shall provide for the proportional reduction in
4	payments to individual students to the extent that the total of such payments would exceed the amount
5	of the block grant. The agreement shall give priority to offsetting enrollment fee increases over other
6	education-related financial support.
7	(2) Any block grant agreement between the Department and City College shall provide,
8	as a condition of the grant, for the creation of an Oversight Committee to review City College's
9	implementation of the grant agreement and to prepare an annual public report to the Mayor, the Board
10	of Supervisors, and the Department, as well as to City College, concerning the implementation of the
11	grant agreement and disbursements from the Fund. The Oversight Committee shall consist of one
12	member of the Governing Board of City College, one member of the San Francisco Board of
13	Supervisors appointed by the Board of Supervisors, one member of the San Francisco Board of
14	Education appointed by the Board of Education, one City College student representative, two City
15	College faculty members, one City College financial aid counselor or specialist, one member from the
16	office of the Chancellor of City College, and one community member not otherwise eligible to serve on
17	the Oversight Committee. The Oversight Committee shall comply will all applicable provisions of the
18	Brown Act and the Sunshine Ordinance.
19	(3) Notwithstanding the provisions of subsections (c) and (d), the Department shall
20	build and maintain within the Fund a reserve of up to 100% of the estimated annual funding needs for
21	the Fund.
22	
23	Section 2. Effective Date. This ordinance shall become effective 30 days after
24	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
25	

1	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
2	of Supervisors overrides the Mayor's veto of the ordinance.
3	
4	Section 3. Undertaking for the General Welfare. In enacting and implementing this
5	ordinance, the City is assuming an undertaking only to promote the general welfare. It is not
6	assuming, nor is it imposing on its officer and employees, an obligation for breach of which it
7	is liable in money damages to any person who claims that such breach proximately caused
8	injury.
