3 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, CENTRAL
4 ADMINISTRATION, TO ACCEPT RETROACTIVELY AND EXPEND A GRANT IN THE
5 AMOUNT OF \$101,976 FROM THE UNIVERSITY OF CALIFORNIA UNIVERSITYWIDE
6 AIDS RESEARCH PROGRAM (UARP) TO STUDY THE IMPACT OF CARE
7 COORDINATION ON HEALTH CARE ACCESS AND HEALTH STATUS IN SAN
8 FRANCISCO AND TO ENTER INTO AN AGREEMENT FOR THE USE OF THESE FUNDS;
9 PROVIDING FOR RATIFICATION OF ACTION PREVIOUSLY TAKEN.

10 WHEREAS, The Department of Public Health has applied for and been awarded a grant
11 from the University of California Universitywide AIDS Research Program (UARP), in the
12 amount of \$101,976 to fund a study of the impact of care coordination services on health care
13 access and health status in San Francisco; and,

14 WHEREAS, As a condition of receiving the grant funds, the UARP requires the City to
15 enter into an agreement (the “Agreement”); a copy of which is on file with the Clerk of the
16 Board of Supervisors in File No. 001791 ; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$15,771; now,
18 therefore, be it

19 RESOLVED, That the Department of Public Health is hereby authorized to accept
20 retroactively and expend the grant funds pursuant to San Francisco Administrative Code Section
21 10.170-1; and, be it


22 FURTHER RESOLVED, That the Director of Health is authorized to enter into the

24 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of






