2 APPOINTING SEVEN MEMBERS TO THE SUSTAINABLE FUNDING FOR SCHOOL ARTS
3 AND MUSIC TASK FORCE, WAIVING RESIDENCY REQUIREMENTS.

5 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
6 does hereby appoint the hereinafter designated persons to serve as members of the
7 Sustainable Funding for School Arts and Music Task Force, pursuant to the provisions of
8 Resolution No. 1127-99 for the term specified:

10 Jamar Grundy, (Seat No. 1, at-large member who shall be a student in the San
11 Francisco Unified School District), new term to be determined;

12 Gail Baugh, (Seat No. 2, at-large member who shall be a parent of a student in the
13 San Francisco Unified School District), new term to be determined;

14 Robert Landis, (Seat No. 3, at-large member who shall be a teacher in the San
15 Francisco Unified School District), new term to be determined;

16 Marlene Sarizky, (Seat No. 4, at-large member representing the interests of the
17 business community), new term to be determined;

18 Margaret Brodtkin, (Sea No. 6, at-large member representing a youth advocacy
19 organization), new term to be determined;

20 Brenda Berlin, (Seat No. 7, at-large member representing an arts advocacy
21 organization), new term to be determined;

23 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 1 1 . The membership of the Sustainable Funding for School Arts and Music Task Force
2 has a goal to be representative of the diversity of the City and County of San
3 Francisco.
- 4 2 . Applicant Larry Harper, a new appointee, who is not a resident of San Francisco, is
5 a person with experience that uniquely qualifies him/her to serve on the
6 Sustainable Funding for School Arts and Music Task Force.
- 7 3 . The Sustainable Funding for School Arts and Music Task Force has attempted to
8 fill the position, for which Larry Harper was nominated, with an individual who is a
9 City resident and who has the specific experience, skills, and qualifications, but has
10 been unable to do so at this time. The Rules Committee has certified that Larry
11 Harper is qualified to serve on the Sustainable Funding for School Arts and Music
12 Task Force.
- 13 4 . After exercising due diligence, the Board of Supervisors concludes that there is no
14 other possible representative, who is a resident of San Francisco and who has the
15 specific experience, skills, or qualifications possessed by this applicant, and who is
16 willing to serve on the Sustainable Funding for School Arts and Music Task Force
17 at this time; and, be it

18 FURTHER RESOLVED, That the Board of Supervisors waives the residency
19 requirement for Larry Harper, as allowed in cases where no qualified City resident, willing to
20 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
21 appointed to boards, commissions, and advisory bodies established by legislative act of the
22 Board of Supervisors to be resident(s) of the City and County of San Francisco.




