4 **Resolution responding to the Presiding Judge of the Superior Court on the**
5 **recommendations contained in the 2006-2007 Civil Grand Jury Report entitled**
6 **“Continuity Report - Have City Agencies Done What They Said They Would Do After the**
7 **Civil Grand Jury of 2005-2006 Issued Its Reports?”.**

8 WHEREAS, Under California Penal Code Section 933 et seq., the Board of
9 Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior
10 Court on the recommendations contained in Civil Grand Jury Reports; and,

11 WHEREAS, In accordance with Penal Code Section 933.05(c), if a finding or
12 recommendation of the Civil Grand Jury addresses budgetary or personnel matters of a
13 county agency or a department headed by an elected officer, the agency or department head
14 and the Board of Supervisors shall respond if requested by the Civil Grand Jury, but the
15 response of the Board of Supervisors shall address only budgetary or personnel matters over
16 which it has some decision making authority; and,

17 WHEREAS, The 2006-2007 Civil Grand Jury Report entitled “Continuity Report - Have
18 City Agencies Done What They Said They Would Do After the Civil Grand Jury of 2005-2006
19 Issued Its Reports?” is on file with the Clerk of the Board of Supervisors in File No. 071335,
20 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

21 WHEREAS, Recommendation No. 3 of the subject Civil Grand Jury Report states: “The
22 Board of Supervisors should respond to each individual recommendation directed to it by the
23 Civil Grand Jury. The responses should be made to the Presiding Judge of the Superior
24 Court within 90 days of the release of the report”; and,

1 WHEREAS, Recommendation No. 4 states: "The Board of Supervisors should continue
2 to hold hearings on the reports issued by the Civil Grand Jury"; and,

3 WHEREAS, in accordance with Penal Code Section 933.05(c), the Board of
4 Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior
5 Court on the Recommendation Nos. 3 and 4 contained in the subject Civil Grand Jury Report;
6 now, therefore, be it

7 RESOLVED, That the Board of Supervisors reports to the Presiding Judge of the
8 Superior Court that it agrees with Recommendation Nos. 3 and 4 of the 2006-2007 Civil
9 Grand Jury Report entitled "Continuity Report - Have City Agencies Done What They Said
10 They Would Do After the Civil Grand Jury of 2005-2006 Issued Its Reports?"; and be it

11 FURTHER RESOLVED, That the Board of Supervisors urges the Mayor to cause the
12 implementation of accepted recommendations through his/her department heads and through
13 the development of the annual budget; and, be it

14 FURTHER RESOLVED, That the Board of Supervisors urges City departments
15 responsible for recommendations not necessitating a response from the Board of Supervisors
16 to provide a status report to the Board of Supervisors on implementation of said
17 recommendations within six months of the passage of this resolution.
