

1 [Accept-Expend Federal Grant]
2 AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TO APPLY FOR, ACCEPT AND
3 EXPEND A GRANT IN THE AMOUNT OF \$3,982,000 IN FEDERAL SURFACE
4 TRANSPORTATION PROGRAM FUNDS WITH REQUIRED LOCAL MATCHING FUNDS OF
5 \$515,911 FOR THE LAKE MERCED PAVEMENT RENOVATION PROJECT.

7 WHEREAS, The San Francisco County Transportation Authority has
8 recommended programming \$3,982,000 in STP/CMAQ funds for the
9 Department of Public Works' (DPW) for Phase 2 of the pavement
10 renovation project on Lake Merced Boulevard, as part of the upcoming
11 2000 Transportation Improvement Program, to be adopted by the
12 Metropolitan Transportation Commission and approved by the Federal
13 Highway Administration (FHWA); and,

14 WHEREAS, The federal funding will cover 88.5 percent of eligible
15 costs as defined by the FHWA and administered by the California
16 Department of Transportation; and,

17 WHEREAS, Indirect costs are ineligible according to FHWA rules
18 and regulations; and,

19 WHEREAS, The non-federal share will be paid for with local half-
20 cent sales tax administered by the San Francisco County
21 Transportation Authority totaling \$515,911; and,

22 WHEREAS, The Department of Public Works understands that the
23 total amount of STP funds for the aforementioned projects is fixed at
24 \$3,982,000, and that any cost increases incurred by the Department in
25 delivering this projects must be funded by the Department from its

1 local matching funds, and that the Department of Public Works does
2 not expect any cost increases to be funded with STP funds; now,
3 therefore, be it

4 RESOLVED, That this Board of Supervisors does hereby authorize
5 the Director of Public works to apply for, accept and expend up to
6 \$3,982,000 in federal Surface Transportation Program funds with
7 required local matching funds of \$515,911 for the Lake Merced
8 Pavement Renovation Project and to execute any and all documents
9 therefore.




