11 officer or member who represent nonprofit organizations that provide services related to the
12 City's beautification and neighborhood cleanup programs, for the unexpired portion of a two-
13 year term ending April 10, 2019.

14 Alex Mitra, seat 14, succeeding Dee Dee Workman, term expired, must represent
15 business that operates in San Francisco and either seat 14 or 15 must be a property owner,
16 for the unexpired portion of a two-year term ending April 10, 2019.

17 Daniel Kling, seat 15, succeeding themselves, term expired, must represent business that
18 operates in San Francisco and either seat 14 or 15 must be a property owner, for the
19 unexpired portion of a two-year term ending April 10, 2019.

20 Rebecca Delgado Rottman, seat 16, succeeding herself, term expired, must be an
21 employee or officer of a private school or art school who operate in San Francisco, for the
22 unexpired portion of a two-year term ending April 10, 2019.
