3 **Ordinance authorizing settlement of the lawsuit filed by Bryn Miller against the City and**
4 **County of San Francisco for \$95,000; the lawsuit was filed on April 30, 2024, in San**
5 **Francisco Superior Court, Case No. CGC-24-614320; entitled Bryn Miller v. City and**
6 **County of San Francisco, et al.; the lawsuit involves an alleged personal injury arising**
7 **from a vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Bryn Miller v. City and County of San
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-24-614320 by the payment of
13 \$95,000. The lawsuit involves an alleged personal injury arising from vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April
15 30, 2024, and the following parties were named in the lawsuit: Plaintiff Bryn Miller;
16 Defendants City and County of San Francisco and Anthony Montoya.
