11 honored at the tenth annual Women At The Center Honors (WATCH) luncheon; and

12 WHEREAS, Patricia (Trish) Tatum Otsott served The Junior League of San Francisco,
13 Inc., as President (1998-99); co-chair of The Junior League Centennial Celebration; Sustainer
14 Council Director; Grant Making Council and Community Programs Council Director; State
15 Public Affairs Delegate; Chair of the Next-to-New Shop; and was awarded the Sustainer of the
16 Year; and

17 WHEREAS, Trish Otsott served Stephen Minister, Deacon, and Librarian of the
18 Calvary Presbyterian Church; President, Saint Francis Hospital Board Member and Auxiliary
19 Chair of the Gift Shop; The Metropolitan Club, Vice President; San Francisco League of the
20 San Francisco Symphony, President and Ex Officio Board Member; Point of Light, winner;
21 appointed to State Board of Cosmetology and Library of California; Trustee; founder of
22 Jackson Street Watch and Chinatown Revisited; and numerous other honors; and

23 WHEREAS, Roselyne Chroman Swig is the founder and president of Comcon
24 International; Roselyne C. Swig Artsource; and Partners Ending Domestic Abuse and her
25 Board memberships include: KQED; NPR Foundation; Mills College, Lifetime Trustee; SF Art

4 WHEREAS, Roselyne Swig is a 2013 Advanced Leadership Initiative Fellow at Harvard
5 University and has served as past president of SF Arts Commission and as a member of SF
