15 purposes, and to add Appendix D, entitled Civil Service Provisions; Glossary, pursuant to
16 Section VI.C of the Memorandum of Understanding, which provides for modifications by
17 mutual consent of the parties. The amended provisions so implemented are on file in the
18 office of the Board of Supervisors.


