16 Section 1. The Board of Supervisors hereby adopts and implements Amendment No. 1
17 to the 2014-2017 Memorandum of Understanding (“MOU”) between the City and County of
18 San Francisco and the International Brotherhood of Electrical Workers Local 6, to implement
19 base wage increases for fiscal years 2017-2018 and 2018-2019 and extend the term of the
20 MOU through June 30, 2019.
