13 approved a Tentative Map for an 8-unit new construction, mixed-use subdivision at 3150  
14 Geary Boulevard, Lot 028 in Assessor's Block No. 1066. Said determination is on file with the  
15 Clerk of the Board of Supervisors in File No. 070985, and is incorporated herein by reference;  
16 now, therefore, be it;
