3 **Ordinance authorizing settlement of the lawsuit filed by Sonia Kominek-Adachi against**  
4 **the City and County of San Francisco and David Serrano Sewell for \$750,000; the**  
5 **lawsuit was filed on February 5, 2024, in San Francisco Superior Court, Case No. CGC-**  
6 **24-612139; entitled Sonia Kominek-Adachi v. City and County of San Francisco et al.;**  
7 **the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Sonia Kominek-Adachi v. City and  
12 County of San Francisco et al., San Francisco Superior Court, Case No. CGC-24-612139 by  
13 the payment of \$750,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 February 5, 2024, and the following parties were named in the lawsuit: Plaintiff Sonia  
16 Kominek-Adachi, and defendants City and County of San Francisco and David Serrano  
17 Sewell.
