Ordinance authorizing settlement of the lawsuit filed by Sam Percival Stewart against the City and County of San Francisco for \$150,000; the lawsuit was filed on June 2, 2016, in San Francisco Superior Court, Case No. CGC-16-552341; entitled <u>Sam</u> <u>Percival Stewart v. City and County of San Francisco et al.</u>, removed to federal court on November 22, 2016, and re-captioned as <u>Sam Percival Stewart v. City and County of</u> <u>San Francisco et al.</u>, United States District Court, Case No. 3:16-cv-6744; the lawsuit involves an alleged civil rights violation; other material terms of the settlement are waiver of the Zuckerberg San Francisco General Hospital lien in the amount of \$735.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Sam Percival Stewart v. City and</u> <u>County of San Francisco et al.</u>, United States District Court, Case No. 3:16-cv-6744 by the payment of \$150,000 and waiver of the Zuckerberg San Francisco General Hospital lien in the amount of \$735. The lawsuit involves an alleged civil rights violation.

Section 2. The above-named action was filed in Superior Court of the City and County of San Francisco on June 2, 2016, initially entitled <u>Sam Percival Stewart v. City and County of San Francisco, et al.</u>, San Francisco Superior Court CGC-16-552341 and removed to the United States District Court on November 22, 2016, and re-captioned as <u>Sam Percival Stewart v. City and County of San Francisco et al.</u>, and the following parties were named in the lawsuit: Plaintiff: Sam Pervical Stewart; Defendants: City and County of San Francisco, Thomas E. Mora, James Miller and Yasar Shah.


