10 WHEREAS, Shawn Higgins is seeking the issuance of a Type 42 on-sale beer
11 and wine public premises license for D & H Sustainable Jewelers, located at 2323
12 Market Street; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
20 on-sale beer and wine public premises license to Shawn Higgins for D & H Sustainable
21 Jewelers, located at 2323 Market Street, will serve the public convenience or necessity
22 of the people of the City and County of San Francisco.

23 Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be
24 permitted only between the hours of 11:00 a.m. - 10:00 p.m. daily. (2) No noise shall be
25 audible beyond the area under the control of the licensee. (3) Loitering (loitering is

1 defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on
2 any sidewalks or property adjacent to the licensed premises under the control of the
3 licensee. (4) The interior lighting maintained therein shall be sufficient to make easily
4 discernible the appearance and conduct of all persons and patrons in that portion of the
5 premises where alcoholic beverages are sold, served, delivered or consumed. (5) No
6 person under the age of 21 shall sell or deliver alcoholic beverages. (6) No more than
7 5% of the square footage of the premise will be used for the on-sale services,
8 consumption and display of alcoholic beverages. (7) Petitioner shall not make structural
9 changes in the premises interior without prior written approval from the Department. (8)
10 The sale of alcoholic beverages for off-sale is strictly prohibited. (9) The sales and
11 service of alcoholic beverages shall be incidental to the premises primary business the
12 sale of jewelry.


Dear Board of Supervisors,



EXHIBIT A

AUTHORIZATION

This authorization is for a conditional use to allow a bar to be located within the existing retail jewelry store (d.b.a D&H Sustainable Jewelers) at 2323 Market Street, Block 3563, Lot 030 pursuant to Planning Code Section(s) 721.41, 790.22, and 303 within the Upper Market NCD and a 50-X Height and Bulk District, in general conformance with plans, dated December 9, 2010, and stamped "EXHIBIT B" included in the docket for Case No. 2010.1095C and subject to conditions of approval reviewed and approved by the Commission on March 17, 2011 under Motion No 18296. This authorization and the conditions contained herein run with the property and not with a particular Project Sponsor, business, or operator.

RECORDATION OF CONDITIONS OF APPROVAL

Prior to the issuance of the building permit or commencement of use for the Project the Zoning Administrator shall approve and order the recordation of a Notice in the Official Records of the Recorder of the City and County of San Francisco for the subject property. This Notice shall state that the Project is subject to the conditions of approval contained herein and reviewed and approved by the Planning Commission on March 17, 2011 under Motion No. 18296.

PRINTING OF CONDITIONS OF APPROVAL ON PLANS

The conditions of approval under the 'Exhibit A' of this Planning Commission Motion No. 18296 shall be reproduced on the Index Sheet of construction plans submitted with the Site or Building permit application for the Project. The Index Sheet of the construction plans shall reference to the Conditional Use authorization and any subsequent amendments or modifications.

SEVERABILITY

The Project shall comply with all applicable City codes and requirements. If any clause, sentence, section or any part of these conditions of approval is for any reason held to be invalid, such invalidity shall not affect or impair other remaining clauses, sentences, or sections of these conditions. This decision conveys no right to construct, or to receive a building permit. "Project Sponsor" shall include any subsequent responsible party.

CHANGES AND MODIFICATIONS

Changes to the approved plans may be approved administratively by the Zoning Administrator. Significant changes and modifications of conditions shall require Planning Commission approval of a new Conditional Use authorization.

Conditions of Approval, Compliance, Monitoring, and Reporting PERFORMANCE

1. **Validity and Expiration.** The authorization and right vested by virtue of this action is valid for three years from the effective date of the Motion. A building permit from the Department of Building Inspection to construct the Project and/or commence the approved use must be issued as this Conditional Use authorization is only an approval of the proposed Project and conveys no independent right to construct the Project or to commence the approved use. The Planning Commission may, in a public hearing, consider the revocation of the approvals granted if a site or building permit has not been obtained within three (3) years of the date of the Motion approving the Project. Once a site or building permit has been issued, construction must commence within the timeframe required by the Department of Building Inspection and be continued diligently to completion. The Commission may also consider revoking the approvals if a permit for the Project has been issued but is allowed to expire and more than three (3) years have passed since the Motion was approved. *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*
2. **Extension.** This authorization may be extended at the discretion of the Zoning Administrator only where failure to issue a permit by the Department of Building Inspection to perform said tenant improvements is caused by a delay by a local, State or Federal agency or by any appeal of the issuance of such permit(s). *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*

DESIGN

3. **Signage.** The Project Sponsor shall develop a signage program for the Project which shall be subject to review and approval by Planning Department staff before submitting any building permits for construction of the Project. All subsequent sign permits shall conform to the approved signage program. Once approved by the Department, the signage program/plan information shall be submitted and approved as part of the site permit for the Project. All exterior signage shall be designed to compliment, not compete with, the existing architectural character and architectural features of the building. *For information about compliance, contact the Case Planner, Planning Department at 415-558-6378, www.sf-planning.org.*

MONITORING

4. **Enforcement.** Violation of any of the Planning Department conditions of approval contained in this Motion or of any other provisions of Planning Code applicable to this Project shall be subject to the enforcement procedures and administrative penalties set forth under Planning Code Section 176 or Section 176.1. The Planning Department may also refer the violation complaints to other city departments and agencies for appropriate enforcement action under their jurisdiction.. *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*

5. **Revocation due to Violation of Conditions.** Should implementation of this Project result in complaints from interested property owners, residents, or commercial lessees which are not resolved by the Project Sponsor and found to be in violation of the Planning Code and/or the specific Conditions of Approval for the Project as set forth in Exhibit A of this Motion, the Zoning Administrator shall refer such complaints to the Commission, after which it may hold a public hearing on the matter to consider revocation of this authorization. *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*

OPERATION

6. **Sidewalk Maintenance.** The Project Sponsor shall maintain the main entrance to the building and all sidewalks abutting the subject property in a clean and sanitary condition in compliance with the Department of Public Works Streets and Sidewalk Maintenance Standards. *For information about compliance, contact Bureau of Street Use and Mapping, Department of Public Works, 415-695-2017, <http://sfdpw.org/>*
7. Patrons are not permitted to consume wine outside of the enclosed building. Sidewalk tables and chairs are not permitted. *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*
8. This Authorization limits the Alcoholic Beverage Control licenses to Type 42. *For information about compliance, contact Code Enforcement, Planning Department at 415-575-6863, www.sf-planning.org.*

No more than 1/3 of the occupied floor area of the commercial tenant space may be dedicated to the sale and service of alcohol for on-site consumption, as designated on the plans marked Exhibit B included in the docket for Case No. 2010.1095C. 10. The hours of operation for the sale and/or service of wine for on-site consumption shall be limited from 9:00a.m. to 10:00p.m., daily, and may only occur while the existing retail use (or any future permitted-by-right use) is open for business. 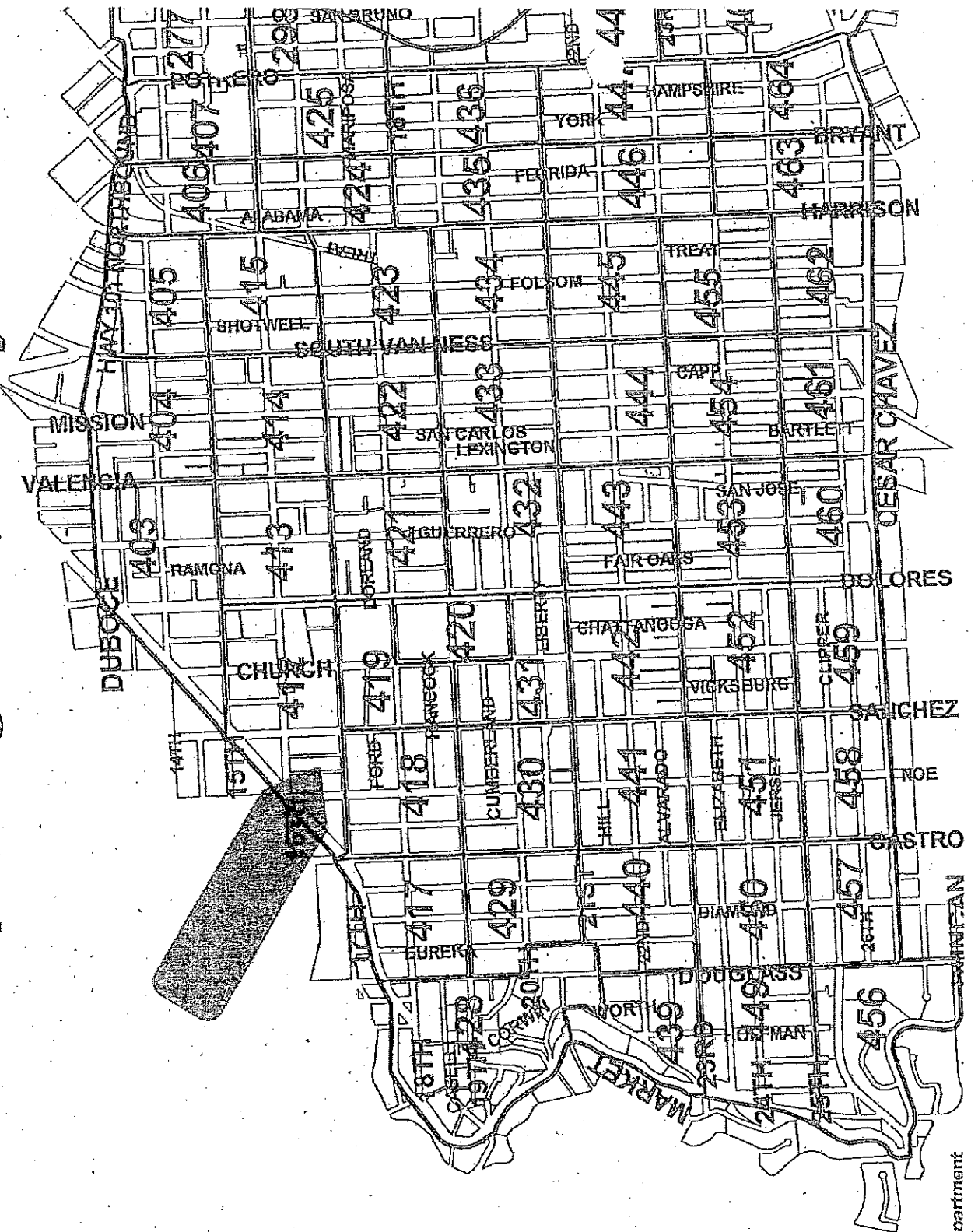

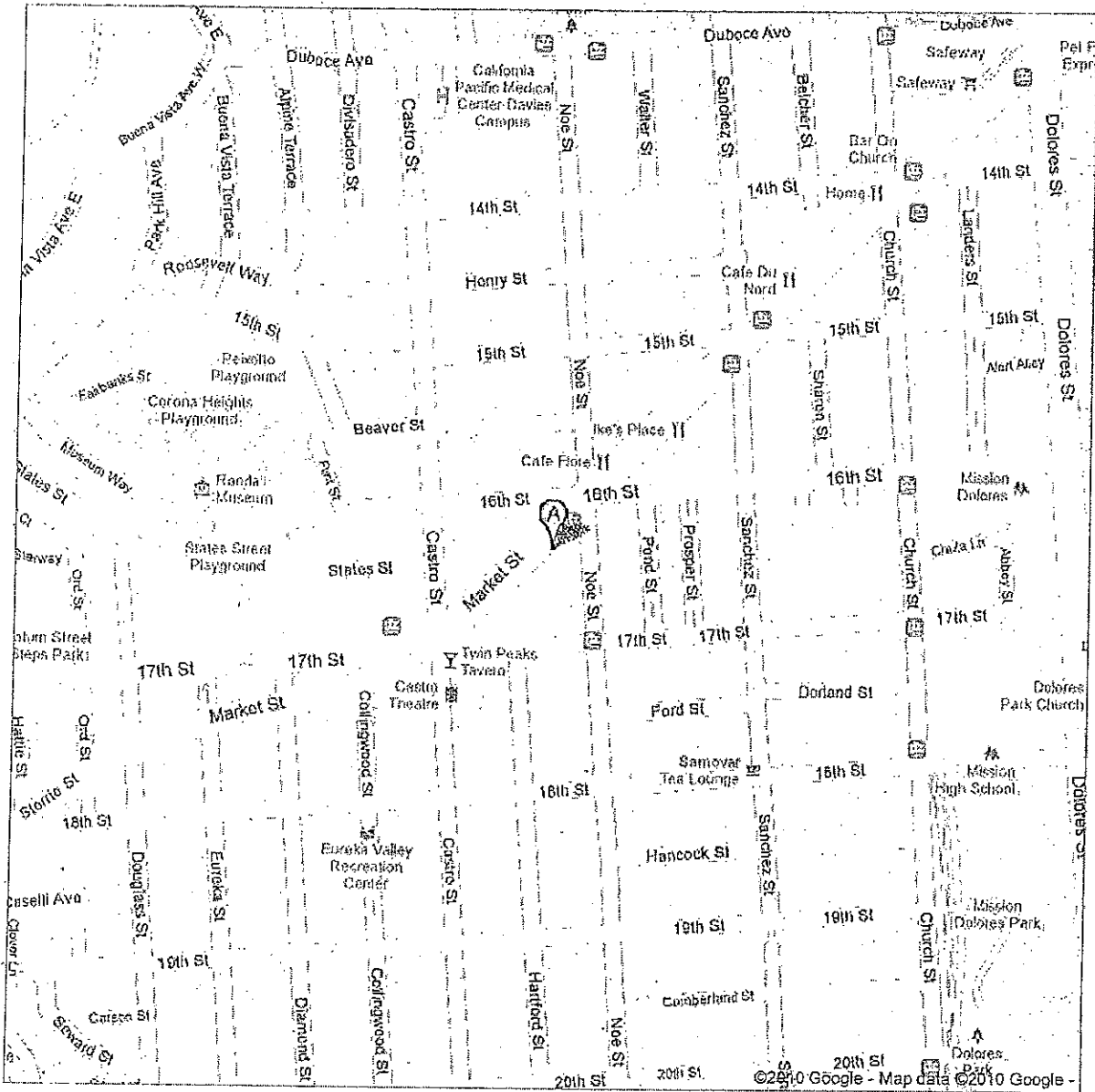

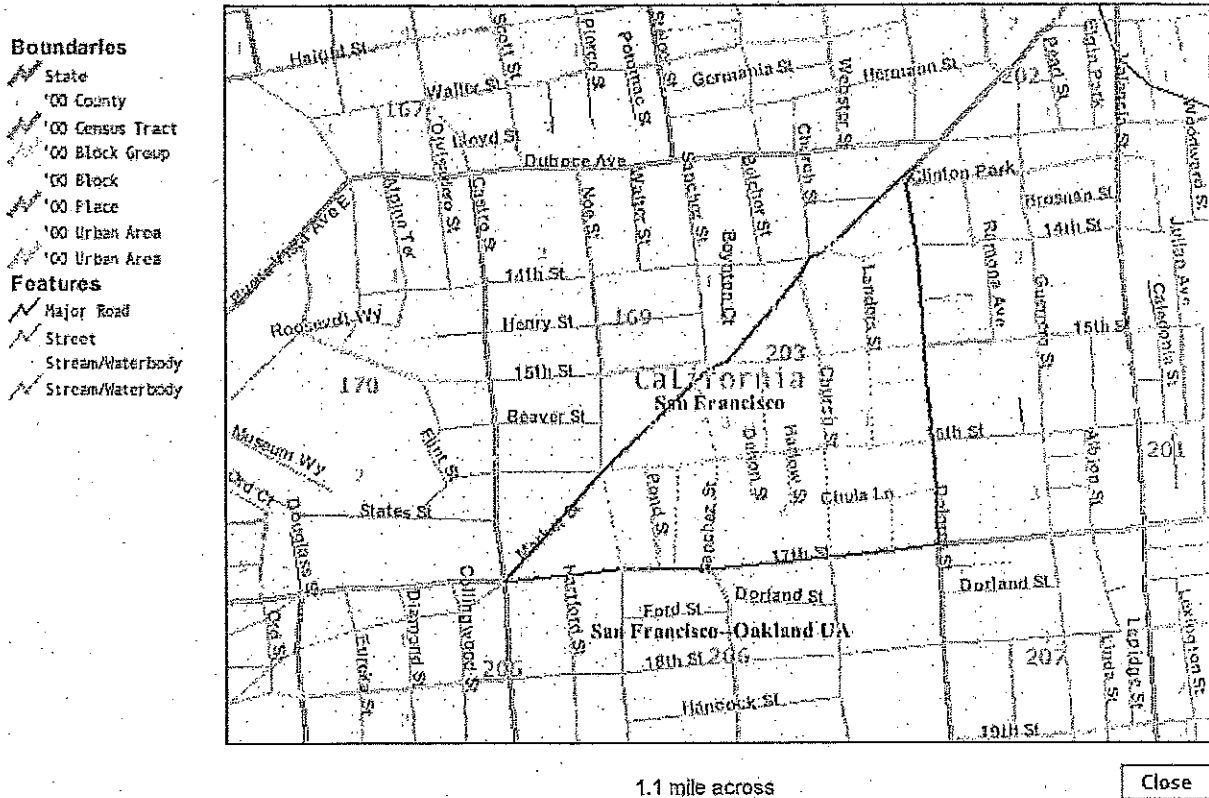
