5 **lawsuit was filed on July 2, 2019, in San Francisco Superior Court, Case No.**
6 **CGC 19-577331; entitled Antoine Fisher, et al., vs. City and County of San Francisco, et**
7 **al.; the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Antoine Fisher, et al., vs. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC 19-577331 by
13 the payment of \$135,000. The lawsuit involves an employment dispute.
