9 that expired June 30, 2005; and

10 WHEREAS, The two parties have recently been through mediation and state fact
11 finding processes with no agreement to date; and,

12 WHEREAS, We all believe more state funding for education is needed to
13 stabilize the finances of the School District; and

14 WHEREAS, The City and County of San Francisco is providing greatly expanded
15 financial assistance through Proposition H funding, a portion of which can be used to
16 funds salary increases; and

17 WHEREAS, The City Controller has been researching possible additional
18 sources of funds such as efficiencies in the Health Service System; and

19 WHEREAS, A third party to the discussions, such as the City Controller, can
20 provide an independent accounting of the costs of proposals that can be relied on by all
21 parties; now therefore be it




