

Who is the People's Budget?

- The largest budget advocacy coalition in this city!
- 150+ member organizations including labor unions, community-based organizations, and nonprofits

How did we get here?

PBC advocated with each of the Supervisors and Chair Chan for months to emphasize the dire budget situation

- Cuts: \$150M overall with huge cuts to children's services (10,000 fewer served), tenant outreach, food provision, and much more
 - Outreach IS direct services! Depts have no plan to replace our community services and the Language Access Ordinance remains unfunded
- Cuts without NOTICE, TRANSPARENCY, or PLANS
 - DPH's Bielenson hearing listed no specific contracts, Dreamkeeper's organizations are in limbo, Free
 City College was decimated without ANY notice
- Funds were used contrary to the will of the voters
 - Sugary Drinks Distributors Advisory Committee's recommendations were slashed, Student Success
 Fund was counted in the Children's Fund, the Dignity Fund was not used to increase senior services
- Community process was IGNORED
 - This Board balanced the budget and restored a fraction of the essential services slashed in the Mayor's budget
 - Last year, the Mayor cut the vast majority of the "addbacks" What trust should the community and the Board have in the budget process if our advocacy wins are immediately cut?



"We have a young lady working for us who is 8 months pregnant and the stress alone of not having stable work is unjust. It's so hard when you're a small organization who now has to turn around and lay people off. This had made us lose trust in the City process: why did we go through all of this, applications and advocacy, just for the City to go back on their word. We're on the ropes but we still keep doing the work because of the promise to the community. We are upholding *our* promise to the community even when the City is not upholding theirs."

Street Violence Intervention Program

Purpose: Restore the 50% cut to the only outreach program to tenants to inform them of their rights

TAY Housing Subsidies

Dept of Homelessness and Supportive Housing (HSH)

\$1M

Purpose: Restore funding for essential housing subsidies for TAY to secure stable housing after transitional housing

Organizations: Homeless Emergency Service Providers Association

Pit Stop Public Restrooms



Dept of Public Works (DPW)

\$800,000

Purpose: Restore just one restroom to 24 hour service

Impact: access to restrooms for members of the public (including the unhoused who have nowhere else to go) and access to a workforce development program
