[Contract funds to the Department of Public Health from Public Health Foundation Enterprises, Inc.]

**Resolution authorizing the San Francisco Department of Public Health (SFDPH), subcontractor, to accept new funding in the amount of \$230,117 to augment an earlier award of \$247,970, for a total of \$478,087 from Public Health Foundation Enterprises, Inc. (PHFE), primary contractor, to fund the SFDPH portion for "San Francisco HIV Vaccine Clinical Trials", a unit of the HIV Vaccine Trials Network (HVTN); retroactively for the period of June 1, 2000 to May 31, 2001.**

WHEREAS, PHFE has revised its earlier award in the amount of \$247,970 to include an augmentation of \$230,117, for a total of \$478,087; and,

WHEREAS, This augmentation created and funded two new positions under the total award; and,

WHEREAS, The augmentation increased the indirect costs to \$33,671 under the total award; and,




