URGING THE DEPARTMENT OF PARKING AND TRAFFIC TO INSTALL CROSSING SIGNALS AT THE CORNERS OF VAN NESS AND MCALLISTER STREETS AND AT VAN NESS AND GROVE STREETS TO FACILITATE SAFER ACCESS TO CIVIC CENTER BUILDINGS.

WHEREAS, The reopening of City Hall has brought hundreds of visitors to the Civic Center daily; and

WHEREAS, The opening of the new Courthouse and a new State office building has increased both pedestrian and vehicle traffic significantly in the Civic Center; and

WHEREAS, Van Ness Avenue carries a heavy traffic load which includes three MUNI lines; and

WHEREAS, Van Ness Avenue is among the widest streets in the City; and

WHEREAS, There are no crossing signals at the corners of Van Ness Avenue and Grove Street, or Van Ness Avenue and McAllister Street; now, therefore, be it

RESOLVED, That the Board of Supervisors finds that the installation of crossing signals at the corners of McAllister and Van Ness and Grove and Van Ness, would facilitate access to City Hall and other Civic Center buildings and better ensure the safety of children and elderly residents who visit City Hall; and be it

FURTHER RESOLVED, That the Board of Supervisors urges the Department of Parking and Traffic to install crossing signals at the corners of Van Ness and McAllister Street and at Van Ness and Grove Street.




