Hearing to consider that the premise-to-premise transfer of a Type-20 off-sale beer and wine liquor license to Mainstay Markets, to do business as Mainstay Markets located at 655-22 Street (District 10) will serve the public convenience or necessity of the City and County of San Francisco. Hearing to consider that the issuance of a Type-90 on-sale general music venue liquor license to The Waterslide LLC, to do business as Brick & Mortar Music Hall located at 1710-1712 Mission Street (District 9) will serve the public convenience or necessity of the City and County of San Francisco. The licensed uniform security guard must be licensed by the State of California, Department of Consumer Affairs.
