

1 [Agreement Amendment - Crestwood Behavioral Health Inc. - Crisis Stabilization Unit - Not to  
2 Exceed \$26,255,566]

3 **Resolution approving Amendment No. 1 to the agreement between the City and County**  
4 **of San Francisco, acting by and through, the Department of Public Health (DPH), and**  
5 **Crestwood Behavioral Health Inc., to provide a Crisis Stabilization Unit at 822 Geary, to**  
6 **extend the term by two years from June 30, 2026, for a new term of March 1, 2025,**  
7 **through June 30, 2028, and to increase the amount by \$17,192,029 for a new total not to**  
8 **exceed amount of \$26,255,566; and to authorize DPH to enter into amendments or**  
9 **modifications to the agreement that do not materially increase the obligations or**  
10 **liabilities to the City and are necessary to effectuate the purposes of the agreement or**  
11 **this Resolution.**

13 WHEREAS, The Department is authorized under Administrative Code, Section 21A.4  
14 to procure from Service Providers directly, without the approval of the Purchaser and without  
15 adhering to the requirements of Section 21.1 or Chapter 14B of the Administrative Code, or  
16 any other applicable competitive procurement requirement; and

17 WHEREAS, The contract is consistent with the Civil Service Commission’s approval  
18 obtained on February 3, 2025, under Personal Service Contract number DHRPSC0004912;  
19 and

20 WHEREAS, On March 1, 2025, DPH and Crestwood Behavioral Health Inc. entered  
21 into an agreement to provide a Crisis Stabilization Unit at 822 Geary (“Original Agreement”),  
22 which uses the program name of 822 Geary CSU; and

23 WHEREAS, The Original Agreement has a term of March 1, 2025, through June 30,  
24 2026, and a not to exceed amount of \$9,063,537; and

1           WHEREAS, DPH wishes to amend the agreement by extending the term to June 30,  
2 2028, and increasing the maximum expenditure by \$17,192,029 (the "First Amendment"); and

3           WHEREAS, Charter, Section 9.118(b), requires Board of Supervisors approval by  
4 Resolution of any contract which, when entered into, extends over 10 years, and of any  
5 contract which, when entered into, costs the City \$10,000,000 or more; and

6           WHEREAS, The proposed amendment contained in File No. 260418, is substantially in  
7 final form, with all material terms and conditions included, and only remains to be executed by  
8 the parties upon approval of this Resolution; now, therefore, be it

9           RESOLVED, That the Board of Supervisors hereby approves the amendment in  
10 substantially the form contained in File No. 260418; and, be it

11           FURTHER RESOLVED, That the Board of Supervisors authorizes DPH to make any  
12 modifications to the amendment, prior to its final execution by all parties, that DPH  
13 determines, in consultation with the City Attorney, are consistent with this Resolution, in the  
14 best interest of the City, do not materially increase the obligations or liabilities of the City, are  
15 necessary or advisable to effectuate the purposes of the amendment, and are in compliance  
16 with all applicable laws, including the City's Charter; and, be it

17           FURTHER RESOLVED, That within 30 days of the amendment being fully executed by  
18 all parties, DPH shall submit to the Clerk of the Board of Supervisors a completely executed  
19 copy for inclusion in File No. 260418; this requirement and obligation resides with the  
20 Department, and is for purposes of having a complete file only, and in no manner affects the  
21 validity of approved amendment.

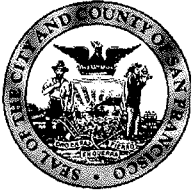
