3 **Resolution consolidating the City and County of San Francisco Municipal Election to**
4 **be held on November 3, 2015, with the City College of San Francisco Governing Board**
5 **Election and the City and County of San Francisco Special Bond Election; and**
6 **providing that the election precincts, voting places, and officers for these elections**
7 **shall be the same as for the State General Election.**

8

9 WHEREAS, The City and County of San Francisco will hold a municipal election on
10 November 3, 2015, for the purpose of voting on candidates for City office, as well as proposed
11 local ballot measures to be submitted to the voters; and

12 WHEREAS, The San Francisco Community College District will hold an election on
13 November 3, 2015, for the purpose of voting on candidates for the Governing Board of the
14 Community College District; and

15 WHEREAS, The Board of Supervisors called a special election to be held in the City
16 and County of San Francisco on November 3, 2015, for the purpose of voting on a proposed
17 general obligation bond measure, and consolidated the special municipal bond measure
18 election with the State Primary Election scheduled for the same date; and

19 WHEREAS, The Board of Supervisors believes that it is in the best interests of the
20 public that these elections be consolidated, as authorized by law; now, therefore, be it

21 **RESOLVED**, That pursuant to California Elections Code, Sections 10400, et seq., the
22 City and County of San Francisco municipal election, the City College of San Francisco
23 Governing Board election, and City and County of San Francisco special municipal bond
24 election on November 3, 2015, shall be and hereby are consolidated; and, be it

1 FURTHER RESOLVED, That pursuant to California Elections Code, Section 10002,
2 the San Francisco Community College District shall reimburse the City and County of San
3 Francisco for the election services performed for each district; and, be it

4 FURTHER RESOLVED, That the voting precincts, polling places, and officers of the
5 the City and County of San Francisco municipal election, City College of San Francisco
6 Governing Board election, and City and County of San Francisco special municipal bond
7 election, shall, in every case, be the same; that there shall be only one set of election officers
8 in each precinct, to wit, the election officers to be appointed by the Director of Elections for
9 each precinct; that all candidates, ballot measures and bond proposals shall be set forth on
10 the ballots provided for said election; that the elections shall be held in all respects as though
11 there were only one election, and that all returns shall be canvassed by the Director of
12 Elections as provided in the California Elections Code.


