12 waiver of the San Francisco General Hospital lien.

13 Section 2. The above-named action was filed in the United States District Court,
14 Northern District of California on December 10, 2010, and the following parties were named in
15 the lawsuit: Plaintiff Kevin Woodson; Defendant City and County of San Francisco and Adam
16 Eatia.
