

4 **retroactively accept and expend a grant of \$39,884 from Sacred Heart Cathedral**
5 **Preparatory to support a half-time gardener at Crocker Amazon Field.**

7 WHEREAS, Sacred Heart Cathedral Preparatory (SHCP) is a non-profit, private high
8 school located in San Francisco's Civic Center neighborhood that uses Crocker Amazon
9 Field, through standard Recreation and Park Department permitting processes, for its
10 athletics programs; and

11 WHEREAS, Crocker Amazon Field had fallen into a state of disrepair in large part due
12 to prevalent gophers; and

13 WHEREAS, Due to the Recreation and Park Department's recent budget crisis, it
14 could not dedicate the resources necessary to improve the condition of the field; and

15 WHEREAS, In 2010, SHCP donated the funds needed to renovate the field; and

16 WHEREAS, In 2010, SHCP also donated the funds needed to maintain the condition
17 of the field by donating the funds necessary to support a half-time gardener; and

18 WHEREAS, Due to a satisfactory working relationship on both side, SHCP would like
19 to renew its support of a half-time gardener's salary; and

20 WHEREAS, SHCP will pay the half-time gardener's salary each month, in arrears,
21 starting on November 1, 2011 and concluding on October 1, 2012; and

22 WHEREAS, SHCP understands that the Recreation and Park Department cannot give
23 priority use or preferential treatment in return for this grant; and

24 WHEREAS, SHCP will have the right to stop monthly payments to the Recreation and
25 Park Department if it feels that the field is not being maintained to an acceptable standard

1 mutually agreed upon by both parties; and


2 WHEREAS, SHCP will pay all necessary rental fees for weekend use; and

3 WHEREAS, The Recreation and Park Commission recommends that the San
4 Francisco Board of Supervisors retroactively accept and expend the grant of \$39,884; and

5 WHEREAS, The City recognizes the generosity of Sacred Heart Cathedral Preparatory
6 with sincere appreciation; now, therefore, be it

7 RESOLVED, That the Board of Supervisors approves the grant and authorizes the
8 Recreation and Park Department General Manager to retroactively accept and expend the
9 grant of \$39,884 from Sacred Heart Cathedral Preparatory in support of a half-time gardener
10 at Crocker Amazon Field.






