9 WHEREAS, Michael Najib Dabit is seeking transfer of a Type 20 off-sale beer
10 and wine alcoholic beverage control license for Polk and Green Produce located at
11 2222 Polk Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
19 off-sale beer and wine alcoholic beverage control license from 550 Taraval Street to
20 2222 Polk Street for Michael Najib Dabit for Polk and Green Produce, will serve the
21 public convenience and necessity of the people of the City and County of San
22 Francisco.

23 Conditions: 1) No wine shall be sold with an alcohol content greater than 15% by
24 volume except for "Dinner Wines" which have been aged two years or more and
25 maintained in corked bottles. 2) The hours of operation shall not exceed 8:00 a.m. to

1 midnight each day of the week. 3) The petitioner shall be responsible for maintaining
2 free of litter the area in front of and adjacent to the premises over which they have
3 control.




