3 **Ordinance authorizing settlement of the lawsuit filed by Robert Brown against the City**  
4 **and County of San Francisco for \$119,909; the lawsuit was filed on August 13, 2016, in**  
5 **United States District Court, Case No. 16-CV-04671; entitled Robert Brown v. City and**  
6 **County of San Francisco et al.; the lawsuit involves claims of alleged civil rights**  
7 **violation.**

9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Robert Brown v. City and County of  
12 San Francisco, et al., United States District Court, Case No. 16-CV-04671 by the payment  
13 of \$119,909, which includes attorney's fees. The lawsuit involves alleged civil rights  
14 violations.

15 Section 2. The above-named action was filed in United States District Court on  
16 August 13, 2016, and the following parties were named in the lawsuit: plaintiff: Robert Brown;  
17 Defendants City and County of San Francisco, Officer Brent M. Cader #704, Officer  
18 David E Rodriguez #156, Officer, Gabriel Alcaraz, #590, Sergeant, Daniel J. Cole #1135.
