CONTRACT AMENDMENT APPROVAL: Allied Universal Security Services
Residential Employment Information

The Human Services Agency is requesting approval of the resolution amending the contract with Allied Universal Security Services, for the provision of 24/7 unarmed security guard services during the COVID pandemic at various hotel sites throughout the City.

The original contract term was 4/1/2020 – 7/15/2020, with a not to exceed amount of \$9,333,840. With this amendment we are extending the term from 7/16/2020 – 12/31/2020 in an increased amount of \$7,888,248 for a new total not to exceed amount of \$17,222,088.

At the request of Supervisor Walton, we are providing residential employment demographic information for this contract, as well as the new replacement vendors:

Allied Universal Security Services

Out of 200 Security guards employed through this contract, a total of 53 guards are residents of San Francisco: 19 male and 34 female; 90% African American 5% Hispanic and 5% identified as other.

Transitioned Security Contracts

Security Services are being transitioned away from Allied Universal to four separate security vendors (A1 Protective Services, Comprehensive Security Services Inc., Patrol Solutions, and VIP Security Specialist). As of 9/21/20, all Allied Universal sites have been transitioned to these new vendors.

Out of 242 Security guards employed through these contracts so far, a total of 104 guards are residents of San Francisco: 64 male, 38 female, and 2 other; 69% African American, 8% Hispanic and 23% identified as other.
