4 APPROVING FIRST AMENDMENT TO LEASE OF AIRMAIL FIELD POST OFFICE FOR  
5 INCREASE IN ACREAGE AND ADJUSTMENT TO RENTAL TO ALLOW FOR  
6 EXPANSION OF THE AIRMAIL FACILITY BETWEEN UNITED STATES POSTAL  
7 SERVICE AND THE CITY AND COUNTY OF SAN FRANCISCO, ACTING BY AND  
8 THROUGH ITS AIRPORT COMMISSION.

10 WHEREAS, The United States Postal Service leases from the City and County of San  
11 Francisco approximately 5.39 acres comprising Plot 10B for operation of an Airmail Field Post  
12 Office at San Francisco International Airport; and  
13

14 WHEREAS, The United States Postal Service has requested additional acreage  
15 consisting of approximately 3.22 acres to accommodate its Airmail Facility expansion and  
16 modernization under PUC Lease No. 24392; and

18 WHEREAS, On August 4, 1998, pursuant to Resolution No. 98-0196, the Airport  
19 Commission approved that certain First Amendment to Lease, increasing the acreage to 8.60  
20 acres and increase in annual rent to \$511,169; now, therefore, be it

22 retroactive to July 8, 1998

23 RESOLVED, That this Board of Supervisors hereby approves the First Amendment to  
24 Airmail Field Post Office authorizing expansion of premises and increase in annual rental  
25 between United States Postal Service and the City and County of San Francisco, acting by and  
through its Airport Commission.


