3 **Resolution authorizing the Department of the Environment to accept and expend a**
4 **grant in the amount of \$112,000 from the California Department of Conservation for the**
5 **implementation of an Away From Home Recycling Project in the City and County of**
6 **San Francisco.**

7 WHEREAS, Based upon the evaluation of responses to a request for proposals in the
8 area of increasing Away From Home recycling, the California Department of Conservation has
9 selected the Department of the Environment's Recycling Program to be the recipient of
10 \$112,000 in funding to provide recycling bins in Golden Gate Park and the War Memorial and
11 Performing Arts Center; and,

12 WHEREAS, The Commission on the Environment and the Board of Supervisors of the
13 City & County of San Francisco adopted citywide goals of 75% diversion by 2010 and zero
14 waste by 2020; and,

15 WHEREAS, The City's Resource Conservation Ordinance states that City Departments
16 should divert as much solid waste as possible from landfill and maximize purchases of
17 recycled products; and,

18 WHEREAS, There are no public recycling receptacles at Golden Gate Park which
19 hosts more than 16 million visitors per year or the War Memorial and Performing Arts Center
20 which attracts more than 1.3 million concert-goers each year; and,

21 WHEREAS, Approximately 150,000 pounds of empty beverage containers are not
22 recycled from Golden Gate Park and the War Memorial and Performing Arts Center each
23 year; and,

24 WHEREAS, Recycling receptacles with signage at the Golden Gate Park and the War
25 Memorial and Performing Arts Center has the potential to educate millions of visitors to these




